Open houses will be held from 12:00 pm - 3:00 pm on Saturday, March 4, 2017.


For Ohioans who are unable to attend an open house, <u>comments will be accepted online</u>. The online form will be available until Sunday, March 5.

### Northwest Ohio Poacher Sentenced to 4 Years in Prison



On August 4, 2016, State Wildlife Officers from the ODNR Division of Wildlife served an arrest warrant on Robert Mandon Freeworth. The arrest stemmed from a long-term investigation dubbed Operation North Coast that was closed in March 2016 when more than 45 state wildlife officers and investigators executed search warrants and conducted interviews with dozens of subjects.

Freeworth was the main suspect in the northwest Ohio portion of Operation North Coast. He was convicted of engaging in a pattern of corrupt activity, selling venison, tampering with records as well as three counts of tagging, checking or possessing a deer unlawfully.

Freeworth was also convicted of improper handling of a firearm in a motor vehicle. On several occasions he possessed or discharged a loaded firearm while in a motor vehicle. One such incident occurred January 22, 2015, when he shot at three different deer from his vehicle while hunting without permission on three different landowners' properties and with the aid of a spotlight. <u>Continue reading</u>
