Adjust the number of trustees to better reflect the number of trustees over the past few years.

Create two new types of membership in the club.

A new "Social Membership" for Non-Hunting or Trapping membership.

Another new "Family Membership" for a member and his/her spouse.

Article VII

BOARD OF TRUSTEES

Section 1 The management of the club shall be vested in the Board of Trustees consisting of five (5) officers and up to six (6) trustees.

Resolved.

1. The By-Laws of the Black River Game Club shall be amended to read:

Article III

Membership

SECTION 2. Regular Members of the club shall be those persons elected to membership as herein provided, whose membership fees are paid in full and are in good standing. No member may vote unless he has been a club member for thirty (30) days.

SECTION 3. Social Members of the club shall be those persons elected to membership as herein provided, after at least 5 years of Regular Membership, whose membership fees are paid in full and are in good standing.

Social Members shall have NO HUNTING or TRAPPING privileges.
